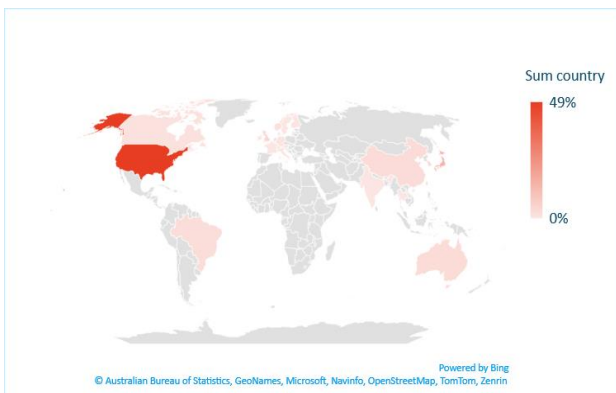
The Vegan World Index, developed by Beyond Investing, and calculated daily by Impact-Cubed, is an actively managed index of global small and mid cap stocks, screened according to vegan and climate-conscious principles and selected according to their relevance to the transition towards a world free of animal exploitation.

The Vegan World Index excludes companies engaged in animal exploitation, defense, human rights abuses, fossil fuels extraction and energy production, and other environmentally damaging activities, and proactively selects those companies whose products and services contribute to the advancement of veganism, tilting towards revenue growth.

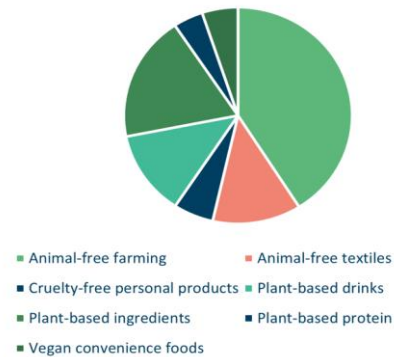
It provides investors with global exposure to growth stocks exposed to the vegan theme.
